- For transfer into Issuer Sponsored Sub Register:**  
You are to submit CDP Form 47B to CDP together with the necessary fees. Barring unforeseen circumstances, it takes a minimum of 7 market days to effect the transfer from the day CDP receives the transfer request. CDP will debit the securities account upon receipt of the request. Please note that the Company Share Registry is responsible for effecting the transfer of securities into your account with Issuer Sponsored Sub Register upon receiving the CHESS Transfer Form and CHESS message from CDP's CHESS custodian, Citicorp Nominees Pty Limited. Transfer fee of S\$10.00 and out-of-pocket expenditures of S\$18.00 are payable per request (subject to 5% GST).
- For transfer into CHESS Sponsored Sub Register:**  
You are to submit CDP Form 47B to CDP together with the necessary fees. You are to instruct your CHESS sponsor to receive securities from CDP's appointed CHESS custodian, Citicorp Nominees Pty Limited. The CHESS Settlement Details are: Citicorp Nominees Pty Ltd, CHESS PID: 20018. Barring unforeseen circumstances, it takes a minimum of 2 market days to effect the transfer from the day CDP and your CHESS Sponsor receive the transfer request. CDP will debit the securities account upon receipt of the request and forward the same to CDP's CHESS custodian who is responsible for effecting the transfer to your CHESS Sponsored Account upon matching of the CHESS message with your CHESS Sponsor. Transfer fee of S\$10.00 and out-of-pocket expenditures of S\$18.00 are payable per request (subject to 5% GST).
- You should ensure that you receive the securities in your Issuer Sponsored Account or CHESS Sponsored Account before trading in Australia Stock Exchange.
- Payment using cheque should be made payable to "The Central Depository (Pte) Limited"
- CDP reserves the right to reject any transfer request where payment of the fees are not made or where the particulars given on this form are incomplete.
