







# About Lion-China Merchants Emerging Asia Select Index ETF

The Lion-China Merchants Emerging Asia Select Index ETF is the world's first Emerging Asia ETF traded in SGD.

### **Investment Objective**

The investment objective of the Fund is to replicate as closely as possible, before expenses, the performance of the iEdge Emerging Asia Select 50 Index using a direct investment policy of investing in all, or substantially all, of the underlying Index Securities.

The Index is compiled and calculated by Singapore Exchange Limited.
The Index aims to track the 50 largest and most tradable companies by
Foreign-Ownership-Adjusted Free-Float Market Capitalisation domiciled in
Emerging Asia countries (i.e. Indonesia, Malaysia, Thailand and India), and listed
on the relevant stock exchanges in Emerging Asia countries or the US Exchanges.








## **Index Characteristics**
